Frequently visit the Scholarship and Financial Aid Webpage of TSU

Starting February 1, 2015, you will be able to apply for the Tennessee State University Foundation Scholarships through the scholarship portal, ACADEMIC WORKS.

If you are an entering freshman, this is the portal by which you will apply for certain scholarships.

One of the things you will need to create is a personal statement. You can get assistance for this type of writing through the Writing Center, located in the Student Success Center (LRC), 310.

You can make an appointment to brainstorm ideas, go over the grammar and "flow" of your statement, and to further assist you in creating the personal statement that will "sell" you.

Also, find more scholarships and internships featured on different TSU webpages by typing scholarship or internships into the Search box found at upper right hand corner of the main TSU webpage, http://www.tnstate.edu

If you find any deadlines in 2014 have passed, consider that those deadlines will most likely repeat themselves in 2015.

2. Fill out your FAFSA early as possible

Many of the TSU Foundation Scholarships and private scholarships require need as one of the criteria for choosing applicants, and they determine that need by your FAFSA.

Waiting until March 2015 to fill out your FAFSA can jeopardize millions.

Information about applying for 2015-2016 has not been posted yet.

The best dates for receiving funds are January 1, 2015-Feb 5, 2015. You should complete your FAFSA form during these dates and submit them online, according to sources in financial aid.

TN-"State Grant - Prior-year recipients receive award if eligible and apply by March 1, 2014. All other awards made to neediest applicants who apply by March 1, 2014, until funds are depleted."

March 1, 2014, was the deadline to receive awards if you are eligible for 2014-2015.

March 1, 2015, will most likely be the deadline to receive awards if you are eligible for 2015-2016.

Free Income Tax Assistance

Many times people are reluctant to fill out the FAFSA because they have not finished filling out their income taxes.

However, the waiting game can be harsh to those who wait later.

You can get income tax assistance to help you with your income tax if you make low to moderate income (less than \$59,000 in 2014).

Scholarships for Students Pursuing a Business Degree

From webpage:

"Application period is September 15th (12:01am), 2014 to December 15th (11:49pm) for the 2015-16 school year.

Each year, the Scarlett Family Foundation will award scholarships in varying amounts based on financial need, that is directly tied to the cost of the college the student attends. The minimum scholarship award is \$2,500 per academic year. The maximum award is \$15,000 per academic year. Scholarships are renewable awards for up to 4 years or until the recipient completes their undergraduate degree, whichever comes first.

Scarlett Family Foundation Scholarships are open to high school seniors and college freshmen, sophomores, and juniors who will graduate or have graduated from high school in 1 of 40 Middle Tennessee counties. Also eligible are individuals who have obtained a GED in the previously named counties prior to June 1, 2015.

Qualified applicants must meet the following criteria:

- 1. Graduated high school (or GED) from one of the eligible counties.
- 2. Demonstrate financial need via 1040 tax return.
- 3. GPA of 2.5 or higher.

- 4. Pursuing a business degree at a 4-yr, non-profit college or university.
- 5. Planning to enroll full-time in the fall of 2015.
